

YOUR MONEY: Should you give your house to your kids?

ou paid \$10,000 for your home shortly after World War II. Now it's worth \$180,000. And you've put it in your son's name, because you worry about its going for medical expenses, or you don't want arguments after you die, or you worry about your estate "being eaten up by inheritance taxes."

You got the idea from some folks at the club luncheon who said they'd given their houses to their kids, and it seemed like a good idea, right?

Wrong.

Suppose your son's job goes bellyup and he must declare bankruptcy. Some of the equity in his own residence is protected, but your home is available to his creditors.

Or what if your daughter-in-law leaves him: Guess what she tries to claim as part of her divorce settlement? (She might or might not succeed, since this was given to, not earned by, your son.)

In the worst scenario your son dies, leaving everything to his wife, who then remarries. Ownership of your home is now in the hands of virtual strangers.

On a more pleasant level: You decide to sell your home and move to a resort area. Taking into consideration the money you've spent on permanent improvements over the years and the costs of selling, you have a profit of \$130,000. And \$125,000 of that is profit free of federal income tax, right?

Wrong.

The house now belongs to your son. Because it isn't his residence, no special homeowner's tax breaks apply.

But at least his profit will be figured only from the \$180,000 the house was

worth when you signed it over to him, right?

Wrong.

Because he received the house as a gift, your son takes over your cost basis and has that same \$130,000 profit. If he had waited to inherit the house, on the other hand, he'd have a stepped-up cost basis, current value at the time of death—death being, of course, the ultimate tax shelter.

But at least you avoided inheritance taxes, right?

Maybe yes, maybe no.

You are allowed to give your son \$10,000 any year with no gift tax due. If you're married and he's married, the figure could go as high as \$40,000. When you gave him a \$180,000 house, \$40,000 of the gift might have been tax-free (depending on your state's own gift tax regulations). But the remaining \$140,000 used up some of the amount you could eventually leave your son free of federal tax at your death.

Federal estate and gift taxes are "unified"—you can turn over a total of \$600,000, during your lifetime and at death, before any federal gift or estate tax is due. (That's on top of anything given or left to a spouse, which can now be transferred free of federal tax consequences at any time.)

Unless your estate, combined with your spouse's, will total more than \$600,000, giving the house to your son didn't avoid any federal estate tax because there wouldn't have been any. (State inheritance taxes do vary, of course, but Uncle Sam's tax would be the big one.)

Even selling a house to your child can have some unexpected tax consequences. Take back an interest-free mortgage and the Internal Revenue Service will "impute" interest, taxing you on as much as 9 percent interest a year that you're not actually receiving.

Timing is also important. Giving a house to a child (other than a minor or one who is handicapped) could affect eligibility for Medicaid benefits in the event you enter a nursing home within 30 months. And gifts made "in anticipation of death" may backfire without giving the desired tax results.

This is not to say giving away your home is always a poor idea. But before you take any such action, discuss the possible consequences with an attorney. Sometimes, for example, it's appropriate to solve some of the problems by retaining life interest in your home. Your life interest can even be scheduled to end if you are more than, say, six months absent from the property in a nursing home.

So it isn't as easy as just sitting around the pool and letting your buddies tell you what they've done. Just as it would be dangerous to take their prescriptions without consulting your own physician, so it's dangerous to adopt their legal actions without consulting your own lawyer.

The disposition of real estate should be considered in the wider framework of estate planning, and professional guidance is essential.

It promises to be a fun evening of food, dancing, singing, laughter and friendship.


